## Payment is for the period 1/04/2019 – 31/03/2020 .

### 1. AS AN EXAMPLE;

If you are a full time Musculoskeletal Physician and re-accrediting through the Faculty/ NZAMM, you will pay the NZAMM subscription, the AFMM subscription and the CPD and Organisational levy.

(ex GST \$310 + \$160 + \$3,000 = \$3,470).

AFMM billed separately. GST is added and a discount is applied for early payment.

### 2. Non-faculty members (Fellows of other medical Colleges) pay only the NZAMM membership fee.

## Payment Process:

Members are requested to email the accounts manager, [accounts@nzamm.org.nz](mailto:accounts@nzamm.org.nz) to confirm their membership status and the amount of their subscription due in the 2019/2020 year.

Upon receipt of this email, the administrator will create a specific tax invoice pertaining to each member in accordance with their subscription due.

Once payment is received (by cheque or direct credit) by the NZAMM Treasurer a receipt will be issued by the administrator if required.
